- 2. Not withstanding any condition unless stated explicitly elsewhere, the terms and conditions set forth in this Agreement shall be understood and interpreted in good faith.
- WHEREAS, both parties of this Agreement have understood and agreed that all
 covenants made under this Agreement shall be governed and shall cease to exist and
 become ineffective in strict adherence to the conditions and procedures laid down in
 the Affiliation Statutes.
- 4. The following documents after incorporating addenda shall be deemed to form and be read and construed as integral part of this Agreement, viz:
 - (a) The Statues including its annexes/schedules, etc.; and,
 - (b) Any other document(s) if required to be attached with this agreement.
- 5. The Scope of this Agreement shall not be amended, modified, or otherwise affected except by mutual consent by both parties hereto. And that, the scope of this Agreement is limited to the extent of written/documented exchange of record between both parties until revised and notified accordingly.
- 6. It is understood that all prior and collateral understandings, agreements, and promises with respect to the Affiliation Statutes have become part of this Agreement and shall not be modified or waived only until approved and notified by the University and shall be binding on both parties of this agreement.
- 7. In case any of the provisions contained in this Agreement shall, for any reason, be held to be invalid, illegal, or unenforceable in any respect, the invalidity, illegality, or unenforceability shall not affect other provision(s) of this Agreement. This Agreement
